Phase 2 – Parking lot (4 stalls missing, need re-striping, reconfiguration

& signage)

Sidewalk - Maximize (current has compliance issues)

Phase 3 – Sanctuary work is okay

Phase 4 – Balcony – low priority (42" guard rail needed) Off limits – make sign

"Do Not Occupy" with disclaimer + signature during transition phase

Barbara will research compliance needs

Drinking Fountains (Tabled as it will invoke code requirements)

Termite extermination – completed (Tom will get bill for Barbara to payment)
